The lack of a clear causal connection in this case series raises concerns about its scientific value and relevance to the broader scientific community. Without stronger evidence or clear patterns, it is difficult to determine its potential contribution to advancing knowledge in the field.	Okay

Is the manuscript scientifically, correct? Please write here.	In my opinion, NO. Based on the reviewed cases in this series, it is evident that the chief complaints of paediatric patients should be evaluated with a broader perspective to establish strong causative links with developmental delays. For instance, while cerebral palsy in a 3-year-old (Case 1) has been attributed to factors such as overindulgence or over-pampering, there is insufficient evidence to substantiate this as a primary cause. Similarly, in Case 2, where a 3-year-old was diagnosed with muscular dystrophy, multiple potential aetiologies should be considered beyond parenting style. Across all cases, the limited age range of 2–4 years poses challenges in drawing definitive conclusions about parenting style as a causative factor. A more comprehensive study focusing on patients aged 14–18 years would provide a better opportunity to analyse parenting styles over an extended developmental period (from ages 1–13) and their correlation with adolescent behaviour. The complexity of diagnosis such as cerebral palsy and muscular dystrophy suggests that multiple biological and environmental factors are likely involved, necessitating a more nuanced investigation. References are sufficient but, he citation from reference 4 is missing in this case series and should be included to ensure completeness and proper attribution. Ensuring accurate and complete referencing is essential for maintaining academic integrity, enhancing the credibility of the findings, and providing readers with the necessary context for further exploration of the cited work. This omission should be addressed promptly to uphold the standards of a reputable journal.	Done as suggested
