If the manuscript is numbered, a few examples can be seen on lines 53 and 65. These results show that literature is a collective noun; its plural has been used..... 81.90, 110;449. A major review of the language is suggested.	Typoglycemia has been reviewed and changed. The subject-verb agreement has been changed on the lines 53 and 65.

However, this manuscript finds a scarcity of the reviewed literature. It is suggested that more research works be added to make this work appealing.	We acknowledge the importance of incorporating recent studies to enhance the comprehensiveness and relevance of our work. However, after an extensive search, we were unable to locate recent studies (2020 onwards) directly related to our research topic.  To address this limitation, we have expounded upon the existing related literature already mentioned in the manuscript.

So, in the conclusion chapter, instead of writing "the researchers will examine," it should be written as "the researchers have examined."	The language has been thoroughly edited to ensure clarity and coherence. Additionally, the use of future tense has been corrected throughout the manuscript, particularly in the conclusion chapter, where phrases such as "the researchers will examine" have been replaced with "the researchers have examined" to accurately reflect the completed research.
Optional/General comments	Population size needs to be rationalized. Why was this sample chosen? A sample size of forty.... Why not 41 or 39? What theoretical framework has been used?
