Optional/General comments	Following are general comments to improve the manuscript: i) Figure numbers shall be given in the text instead of writing “bar chart” or “pie chart” for proper referencing. ii) Table-1 – The percentages given under first and last subheading in the Table is more than 100%. The reasons for that may be given. iii) Table-1 – It has been observed that 64 extension workers were surveyed but the results in the table, under different subheadings, is noted as 65. This needs to be corrected. iv) Table-2: Calculation is based on 62 respondents instead of 64. Needs clarification/correction. v) Table-3: Calculations are based on inconsistent number of respondents (64-65) which is to be corrected and shall be based on the number of extension workers surveyed. vi) Figure-3: Results are based on 63 respondents instead of 64. Need correction or reasons be given for the variation. vii) Conclusions: Shall be based on the study results and may be rewritten accordingly.	Revision made  Correction done
