The alternative is"Probiotic control of animal bacterial infectious diseases"	Thank you for this comment. However, the title of the article is not too general because literatures reviewed in this article indicate that probiotic products have significant prophylactic efficacy against many bacterial diseases and one viral disease (avian influenza). This could be attributed to the fact that most studies on prophylactic efficacy of probiotic products against infectious animal diseases focused on bacterial diseases. If future studies focus on viral diseases, as suggested in the synthesis section of this article, significant prophylactic efficacy of probiotic products against other viral diseases may be demonstrated.

However, apart from the introduction section where climate change is mentioned to describe its effects on the abundance, distribution and transmission of animal pathogens as well as incidence and prevalence of animal diseases; climate change is also mentioned in the conclusion section where the contribution of the use of probiotic products in livestock farming on climate change adaptation and mitigation is briefly described. Corrections have been made by including climate change in the abstract.
