#### Language and Style

- Clarity: The paper's language is generally clear, but some sentences are long and could be simplified for readability. For example, in the introduction, "The health level of banking in Indonesia is listed in OJK regulation No 4/PJOK.03/2016..." could be rewritten for clarity.
- **Grammar and Punctuation**: There are minor issues with grammar and punctuation. For instance, in some cases, commas and periods are missing, or sentences are a bit cumbersome. A thorough proofread for language quality would improve readability.

#### References

Citations: The references section should be reviewed for consistency. Ensure that all citations
are properly formatted according to the journal's style guide. Additionally, check for
completeness, as a few references might be missing essential details (e.g., journal name,
volume, issue number).

### **Overall Contribution**

 The study addresses an important topic in the context of Islamic banking, but it would be strengthened by providing a clearer rationale for selecting the particular factors investigated. - 2. Provide a more detailed methodology section, especially regarding data collection and analysis
- 3. Use tables and charts to present data and statistical results clearly.
- 4. Expand on the implications of the findings in the conclusion.
- 5. Address minor grammatical and language issues throughout the paper.

Once these revisions are made, the paper will be much stronger and more suitable for publication.
