From a scientific perspective, this contribution is very weak. It resembles more of a summary of a small market study than a scientific contribution.

For example: i) They discuss the importance of agriculture and cassava without objectively presenting the significance of cassava production in the agricultural economy. ii) They cite improbable statistics (e.g., "with an average yield of 69,374 kg/ha [5]"), mention derived products without addressing the objectives of the producers. Previous studies have shown that some producers prioritize meeting organoleptic needs over technical requirements such as yield or production cycle (see, for example, Mondo et al., 2019). The authors refer to yield improvements following the adoption of quality seeds but fail to provide supporting data to substantiate their claims. The authors possess quantitative data that could enable an objective understanding of the constraints related to production or profitability (e.g., through regression analysis), yet they choose to present a superficial report based solely on respondents' perceptions. Family labor plays a significant role in agricultural production in developing countries, but the authors remain silent on how they estimated labour inputs. Additionally, they do not calculate the profit margin, which is a key indicator for formulating policy recommendations.
