The article addresses an important social problem; if resolved, it would improve the quality of life in various parts of Africa. It also contributes scientifically for the understanding of African societies and their traditional background. Although the author said the research has been done in Zambia "in four selected communities", there is no further indication what these communities are, which ethnic/cultural backgrounds they represent, etc. As we know, Zambia is a country characterized by a rich diversity. This is why I think international readers would benefit from a more detailed picture of the studied communities.

Optional/General comments	Introduction may benefit from rewriting for concision. The same ideas seem repeated as various bibliographical references are introduced. I believe the international reader would benefit from a detailed introduction of the studied reality (its geographical location, cultural characteristics, ethnic/tribal/linguistic cohesion or division, urban setting vs. traditional ways of life – as I understand, the research was conducted in the city of Lusaka but there is only a short mention of this fact, no further details). Those aspects may seem obvious for the author but they are far from obvious for international readers. As it is, the whole argument sounds very abstract, lacking connection to a concrete cultural reality/ies. Such general expressions as "African societies" prevail, making the reader ask: what societies? Furthermore, such general expressions as "African spirituality" entice the reader's curiosity, making him/her expect exemplification or further details. The author speaks f. ex. about community mediation by elders. Why not to bring about an illustrative example of such an event, showing how it actually works inside an African community? Overall, the paper describes a high degree of generalization, lacking connection to a precisely defined background.
