According to this study, the Niger Delta lost 3,904.00 km2 of its original mangrove area between 1987 and 2022 to other land use/cover types such as water bodies, farmlands, built-up areas for rapid urbanization, oil and gas exploration/exploitation, cleared land, and bare land. These findings should concern many parties who care about the survival of mangrove ecosystems around the world.
